operation up to sixty (60) days from date of purchase as proof of a recent application being submitted. This copy is a temporary certificate valid up to (60) days. Your registration card and/or title will be mailed at a later date. A temporary certificate of number is not valid for rental boats or a boat without a hull id number.

This temporary certificate is only valid for a new watercraft or a watercraft with registration decal(s) and may not be honored in other states. SC Code of Laws, 1976, Section 50-23-345 (d) prohibits duplicating or updating temporary certificates or updating bills of sale.



Letters and numerals must be of a block Letters and numerals must be of a block design not less than three (3) inches high and of a color which clearly contrasts with the color of the watercraft hull. Numbers must be read from left to right as they appear on the certificate of number. Letter groups must be separated from the numerals by hyphens or equivalent spaces, and the year decals must be attached to each side of the watercraft's bow immediately following the number. bow immediately following the number, within six (6) inches (see illustration).
